LPC 247 Comments from Cornwall Councillor - Mr Roy Mann

Councillor Mann reported that attempts to improve traffic issues in the parish included yellow lines in Lower Quarter, white-line re-alignment in Churchtown and the measurement of speed through Castle Gate.

He also expressed his extreme displeasure that no representative from Ludgvan parish had been invited to the announcement of investment by National Rail in the sheds in the sidings at Long Rock.

LPC 248 Chairman's Report

The Chairman reported the latest position in respect of the proposed allocation of a housing site in Long Rock as part of the Penzance & Newlyn Town Framework. Following discussion where it became apparent that no decision was going to come forward without wider consultation it was **RESOLVED that a public meeting be held and representatives of Cornwall Council's planning department be invited to attend.**

LPC 249 Footpath Officers Report

Councillor Ronan stated that there were significant issues with footpaths across Cornwall and that he had recently walked the St Michael's Way in both directions and compiled a sixty-four page report that he was submitting to Cornwall Council.

It was **RESOLVED** that the possibility of establishing a working group to try and improve the situation in the parish be reported back to the next meeting. He also fed back information from the recent AGM of the Cornish branch of the Campaign to Protect Rural England.

LPC 250 Clerk's Report

The Clerk presented his report and it was **RESOLVED that:**

- (a) a written representation to the public inquiry in support of the Friends of Long Rock Mexico Crossing be made;
- (b) the status of volunteers undertaking council maintenance work from an insurance and health & safety perspective be confirmed and the possibility of sponsorship for the maintenance of Tolverth Field be explored.
