The above Order made on 3 June 2021 if confirmed as made, will modify the definitive map and statement for the area by:

Adding a length of Public Footpath in the Parish of Ludgvan commencing at Footpath 59 Ludgvan, approximately 87 metres north-north-west of "Visitor Centre & Café Tremenheere Sculpture Garden", at Ordnance Survey Grid Reference (OSGR) SW 4947/3234 shown as point "A" on the attached Order map, then running in a generally north-westerly, then south-westerly and then north-westerly direction for a distance of 481 metres terminating at its junction with a Public Footpath to be added by this Order, approximately 196 metres south of "Hilly Field Cottage", at OSGR SW 4915/3260 shown as point "B" on the attached Order map.

Adding a length of Public Footpath in the Parish of Madron commencing at its junction with a Public Footpath to be added by this Order, approximately 196 metres south of "Hilly Field Cottage", at OSGR SW 4915/3260 shown as point "B" on the attached Order map, then running in a generally north-westerly then northerly direction for a distance of 205 metres terminating at its junction with Footpath 61 Madron, approximately 41 metres south-west of "Hilly Field Cottage", at OSGR SW 4907/3277 shown as point "C" on the attached order map.

Any representation about or objection to the Order must be sent in writing to the Countryside Access Team Leader, Cornwall Council, Natural Environment Team, P O Box 676, Threemilestone, Truro TR1 9EQ (quoting Reference WCA 578) not later than 22 July 2021, stating the grounds on which they are made. If no representations of objections are duly made to the order, (or to any part of it), or if any so made are withdrawn, the Cornwall Council, instead of submitting the order to the Secretary of State (or part of it if the authority has by notice to the Secretary of State so elected under paragraph 5 of Schedule 15 to the Wildlife and Countryside Act 1981) may itself confirm the order (or that part of the order). If the order is submitted to the Secretary of State (in whole or in part) any representations or objections which have not been withdrawn will be sent with it.
