This Order is made by Cornwall Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Definitive Map and Statement of Public Rights of Way for the former Penwith District area require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely the discovery of evidence which (when considered with all other relevant available evidence) shows that a right of way which is not shown in the Map and Statement subsists or is reasonably alleged to subsist over land in the area to which the Map relates.

The Cornwall Council hereby order that:

1. For the purposes of this order the relevant date is 1 May 2021.
2. The Definitive Map and Statement of Public Rights of Way for the former Penwith District area shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as, "The Cornwall Council (Addition of a Footpath through Woods at Tolver in the Parishes of Ludgvan and Madron) Modification Order 2021".

PART I

Modification of Definitive Map

Description of Path or Ways to be Added

A length of Public Footpath in the Parish of Ludgvan commencing at Footpath 59 Ludgvan, approximately 87 metres north-north-west of "Visitor Centre & Café Tremenheere Sculpture Garden", at Ordnance Survey Grid Reference (OSGR) SW 4947/3234 shown as point "A" on the attached Order map, then running in a generally north-westerly, then south-westerly and then north-westerly direction for a distance of 481 metres terminating at its junction with a Public Footpath to be added by this Order, approximately 196 metres south of "Hilly Field Cottage", at OSGR SW 4915/3260 shown as point "B" on the attached Order map.

A length of Public Footpath in the Parish of Madron commencing at its junction with a Public Footpath to be added by this Order, approximately 196 metres south of "Hilly Field Cottage", at OSGR SW 4915/3260 shown as point "B" on the attached Order map, then running in a generally north-westerly then northerly direction for a distance of 205 metres terminating at its junction with Footpath 61 Madron, approximately 41 metres south-west of "Hilly Field Cottage", at OSGR SW 4907/3277 shown as point "C" on the attached order map.

The total length of Public Footpath to be added to the Definitive Map is 686 metres. The width of the Public Footpath described varies between 1 (one) metre and 8 (eight) metres across open woodland.

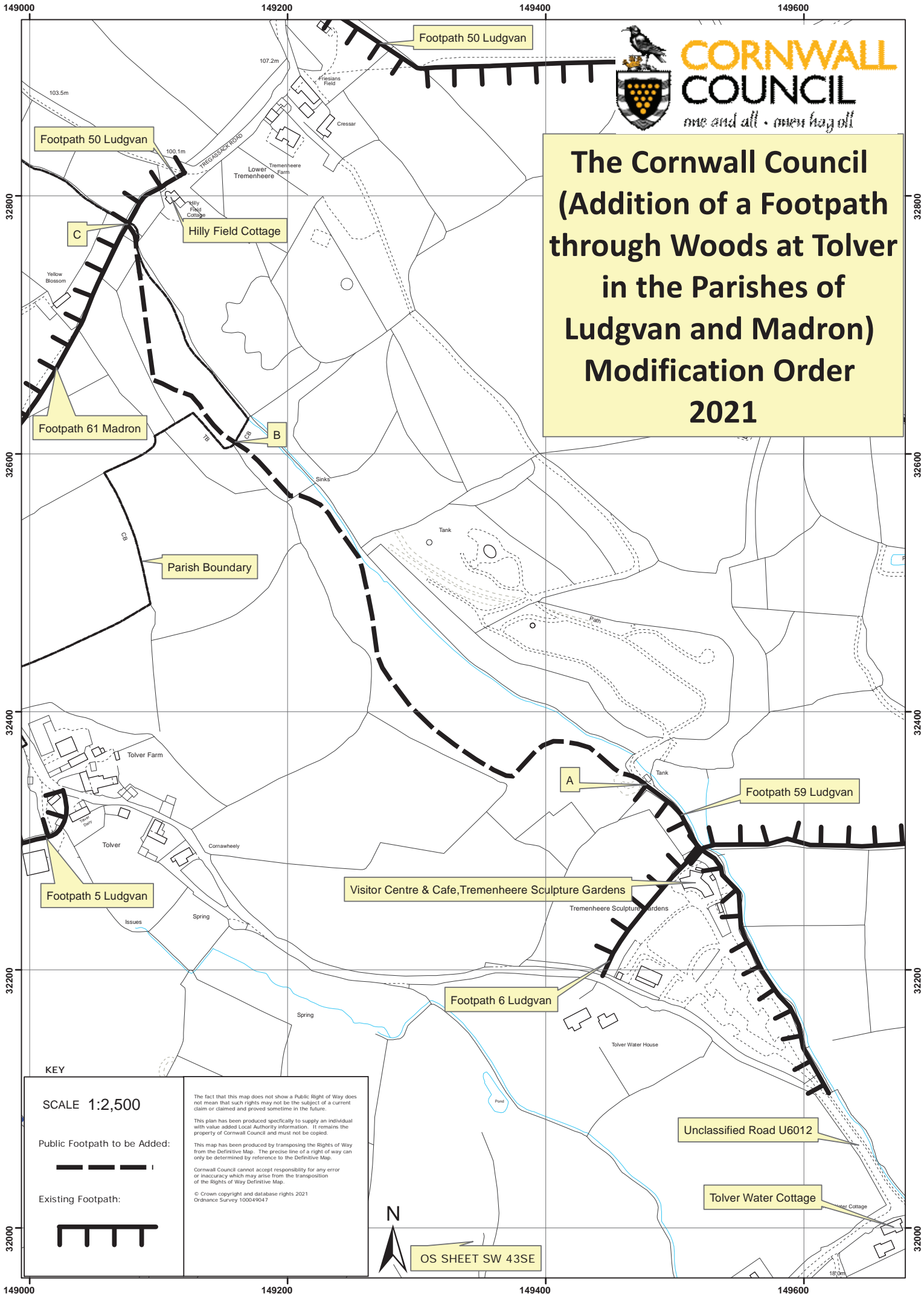
