Summary of the main achievements of the charity during the year	Ludgvan Parish Council took on the trusteeship of the charity in August 2021, after it was handed over from the previous trustees, local community volunteers whose number had depleted to such an extent that the management of the charity needed to change in order to continue.
	When the parish council took on the running of the Long Rock Memorial Institute it had already been closed down for some time, the building had become dilapidated and unsafe for use, and the outdoor area was overgrown.
	The first step that the parish council took was to secure the site by fencing off the entrance from the road, and installing warning signage to deter unauthorised entry to the site.
	An asbestos survey has been carried out on the building, and a quote sought for demolition and clearance of the site. It is simply not a feasible or realistic option to attempt to renovate the existing hall.
	Looking to the future, the parish council (as Trustee), plans to carry out consultation with the local community to seek views on the future use of the site, and the future focus of the charity, to inform the decisions to be taken by the parish council (as Trustee). With a new community hall due to be built in Long Rock, there may be other uses that the property could be put to.
	The parish council (as Trustee) has also opened a new bank account as the banking arrangements of the previous trustees were to be discontinued by the building society they held the funds with. Opening the bank account was delayed by the banks poor processes, but has now been completed. The transfer of the funds from the previous bank account to the new bank account is now underway. Once the funds are able to be accessed by the parish council (as Trustee), the demolition of the building will take place.

Historically, the main sources of funding were income generated through hiring of the hall, likely supported by grant funding.

There has been no expenditure in the year, however the planned expenditure, to cover the cost of demolition of the building, is an action that the charity will carry out as a responsible landowner, to bring the site to a clear and safe condition. Whatever the next use of the site will be, the first prerequisite will be for the site to be safe and clear.
