1. Allotments annual rent charges

£37 per plot, as from 1 January 2022, to be increased to £38 per plot from 1 January 2025.
£50 refundable deposit charged to each tenant when taking up a new plot, refunded upon termination of the plot lease, less the costs of any works needed to clear the plot ready for the next tenant.

2. Burial fees and charges for Crowlas and St Paul’s Cemeteries

2.1 Introduction

Fees, payments and sums fixed and settled by the parish council (Burial Authority for the Parish of Ludgvan) under section 214 of the Local Government Act 1972 and in accordance with the terms of the Local Authorities Cemeteries Order 1977.

Fees effective from 1 March 2022

Levy for non-residents of Ludgvan Parish

These fees apply when the person to be interred, or in respect of whom the right is granted, is, or immediately before his/her death was an inhabitant of the Ludgvan Parish area. In the case of a still-born child, when the parents (or one of them) are, or at the time of interment were residents of Ludgvan Parish . For non-parishioners, all fees are doubled.

A resident is defined as somebody who, immediately prior to their death, was a resident of the Ludgvan parish, or who lived in the area for over ten years and moved out of the area less than 24 months before their death.

Burial fees are doubled for non-residents of the Ludgvan Parish

Where a coffin or casket is oversize or has some other non-standard characteristic, the parish council reserves the right to charge an additional fee commensurate with any extra costs involved.

The interment fee does not cover the cost of digging the grave. Your funeral director will advise you in relation to these costs. It covers administrative and ongoing maintenance costs in respect of the cemeteries (except in relation to Memorials).

All fees should be made payable to Ludgvan Parish Council and addressed to the clerk. Invoices will be issued and payment instructions included on the invoices. The council's preferred payment method is by direct banking payment/BACS.

2.2 Purchase of Exclusive Right of Burial – 100 years

| Note: Fees in this section are in addition to interment fees | Fee |

| Exclusive Right of Burial in a grave (maximum two interments) 100 years from date of purchase | £400 |
| Exclusive Right of Burial in a grave (maximum two interments) 50 years from date of first interment | £200 |
| 10 year renewal of Exclusive Right of Burial in a grave | £50 |
| Exclusive Right of Burial in a cremation plot (maximum two interments) | £150 |

2.3 Interment in Grave

2.4 Interment in Cremation Plot

| Scattering of cremated remains in the cemetery – eg on family graves (grave owner written consent needed, along with permission from parish council) | £50 |

2.5 Other Interment Fees

| Walled graves (permission for) | £200 |
| Exhumation of coffin – minimum charge | £500 |
| Exhumation of cremated remains – minimum charge | £300 |

Burial fees are doubled for non-residents of the Ludgvan Parish

2.6 Permission to erect a Memorial

Fees in this section are charged at the same rate, whether resident or non-resident of the parish.
